FUEL SURCHARGE REVISION FOR INTERNATIONAL TICKETS ISSUED ON/AFTER 01 DECEMBER 2023

Dear Valued JAL Business Partners,

The amount of fuel surcharge will be revised again for tickets sold & itineraries originating in Malaysia. The table below summarises the current surcharge compared against the revised surcharge.

1. These changes applicable to all international passenger tickets issued on and after 1st DECEMBER 2023

2. Handling of totally unused tickets on and after 01Dec23 issued on and before 30Nov23

Case1. No change to the tickets

No adjustment is to be made

Case2. Change to the tickets

The new amount is to be applied regardless of the sector changed

3. Notice to the passengers upon booking

Please inform the passengers that the fuel surcharge amount will be revised if tickets are issued on/after 01Dec23 in case that the applicable amounts will be changed.

4. Scheme for the fuel surcharge revision

The fuel surcharge will be reviewed and revised (only when necessary) bimonthly and applied using the following scheme. However, please note that the surcharge level and the period can be varied subject to the relevant governments' approvals.
