



UT TAX FOR DEPARTURE ROUTE STARTING IN BANGLADESH

Dear Valued Partner,

Date: 05Dec23

Please be advised, Bangladesh Government has imposed Travel Tax (UT) on all tickets for international transportation irrespective of place of ticket issuance.

It is now mandatory to collect the **UT tax** on all tickets issued on/after 24 June 2023 and for travel on/after 01 July 2023.

This requirement applies to both FIT and Group reservations made at any time and will be implemented nationwide.

ROUTES

1. TRAVELLING FROM BANGLADESH TO TAX AREA-1 ABOVE VIA ANY POINTS OF AREA-2 OR AREA-3 WITH OR WITHOUT STOP OVER THEN HAVE TO PAY THE TAX APPLICABLE FOR AREA-1.

EXAMPLE - 1- DAC-DXB-CAI. 2- DAC-KTM-HKG.

2. TRAVELLING FROM BANGLADESH TO TAX AREA-2 ABOVE VIA ANY POINTS OF AREA-1 WITH OR WITHOUT STOPOVER- THEN HAVE TO PAY THE TAX APPLICABLE FOR AREA-1.

EXAMPLE - 1- DAC-DXB-CAI-JED. 2- DAC-KMG-RGN.

3. TRAVELLING FROM BANGLADESH TO TAX AREA-2 ABOVE VIA ANY POINTS OF AREA-3 WITH OR WITHOUT STOP OVER- THEN HAVE TO PAY THE TAX APPLICABLE FOR AREA-2.

EXAMPLE - 1- DAC-CMB-DXB. 2- DAC-DEL-TAS.

4. TRAVELLING FROM BANGLADESH TO TAX AREA-3 ABOVE VIA ANY POINTS OF AREA-1 OR AREA-2 WITH STOPOVER HAVE TO PAY THE TAX APPLICABLE FOR THAT VIA POINT AREA. IF NO STOPOVER TAKEN AT VIA POINT - TICKETED WITH -X- MARK- THEN HAVE TO PAY THE TAX APPLICABLE FOR AREA-3.

EXAMPLE - 1- DAC-X/BKK-CMB. 2- DAC-X/KMG-KTM.

6. UN OFFICIALS AND THEIR FAMILY MEMBERS.
7. PASSENGERS TRAVELLING FOR THE SLOLE PURPOSE OF A HAJ PILGRIMAGE.
8. EMPLOYEES OF WORLD BANK / GERMAN VOCATIONAL ORGANIZATION AND JAPAN INTERNATIONAL DEVELOPMENT ORGANIZATION.
-TVL ON/BEFORE 17NOV23
9. PASSENGERS TRANSITING BANGLADESH WITHIN 72HOURS. IN SUCH CASE A TICKET SHOULD BE STAMPED
- STOPOVER AT BANGLADESH UP TO 72 HOURS ONLY.
-TKT/TVL ON/AFTER 18NOV23
10. TRAVELERS IN TRANSIT AND WITHOUT BANGLADESHI VISA STAYING IN BANGLADESH FOR LESS THAN 72 HOURS.

Non-compliance with these regulations may result in the issuance of an ADM (Agency Debit Memo). In the event of a dispute, Malaysia Airlines will apply its discretion for a best resolution which is deemed to be the final decision.
